That's the best way to describe the recently held coroner's jury on the case of Charles Bush who was choked to death while in the custody of Metro Police on July 31, 1990.

It was enough to turn one's stomach to sit as I did for two days and to watch the law-and-order boys, or better still, the good ole boys mete out their sense of justice, even right in the presence of many who are trained in the law.

It was a great white wash because all of the players of this hoax misnamed a coroner's jury were white. The good ole boys made sure that the jury was all white. The hearing officer who was selected by them - the district attorney's office was white. The two lawyers representing the district attorney were white. The officer serving as baliff or runner was white. And the court reporter was also white. The memory of Charles was a black one in that setting.

This charade began with Atty Koot from the District Attorney's Office questioning Charles Bush's girl friend as if she had murdered someone. She was forced to NV 89127.

admit some very intimate sexual relationships she had engaged in. As soon as the time came to examine the police officers who are alleged to have commited this murder, Atty Koot did not ask them a single question. He was as quiet as a church mouse.

Some of the friendly witnesses of Mr. Bush were not called to testify, such as his friend at whose house he had attended a party the night before his death. Nor did the hearing officer call the person Bush's girlfriend was told had heard Mr. Bush cry out, 'Why are you doing this to me?' The great white wash was ended with the hearing officer refusing to ask all of the questions that were given to him from the audience in the courtroom.

Assemblyman Williams to Host NBCSL Meetings in Las Vegas September 7-9

Assemblyman Wendell P. Williams will host two committees of the National Black Caucus of State Legislators (NBCSL) in Las Vegas Sept. 7-9. NBCSL will convene its 15th annual 1991 national convention in Las Vegas.

The two delegations are headed by State Sen. Regis Groff, D-Col. and Assemblywoman Gwen Moore, D.-Calif. Groff chairs NBCSL's by-laws committee and Moore heads a special committee of former NBCSL convention chairpersons.

"Assemblyman Williams serves on the by-laws committee," Groff said, "and we're delighted that he accepted the responsibility to host this very important final session before we meet in December." The Colorado State Senator said decisions made during the Las Vegas meeting would shape the organization for years to come.

NBCSL has nearly 500 African-American lawmakers from 43 states and the Virgin Islands. Groff, one of the NBCSL founders, said one of the major issues under consideration is expanding the number of committees and executive officers and completely overhauling the organization's policies and procedures.

"When NBCSL was first organized some 14 years ago, we could all meet in a phone booth, now that the organization has grown in number and national prominence it is time for a redifinition."

Groff said the by-laws meeting will be held in conjunction with the past-chairpersons meeting chaired by Moore. She was named by NBCSL president to develop set policies and procedures for conducting NBCSL national conventions and other general member-

ship meetings. The Las Vegas convention will be the first to be conducted under the new rules.

"When we were much smaller," Groff said, "it fell largely to the local caucus to develop the program and the agenda. We tended to focus the national convention on local issues."

He said he had suggested to Moore, and she agreed, that the two meetings should be held jointly. "Both committes had to report to the national organization December and some of the members of the by-laws committee are also former convention chairs, including Moore. It just made sense to hold the meetings together.' The Colorado Senator also noted that the decisions of the convention committee may also impact the by-laws.

Groff anticipates the 1991 convention will draw the largest delegation of African-American legislators in NB-CSL history. "Not only has Williams strongly promoted the idea for three years, but we're coming on the eve of the 1992 elections and Las Vegas is an exciting city.

From time to time activities are scheduled in the community that conflict with other activities. The ad hoc


