Resolution To Change City Charter To Be Introduced

Councilman Steve Miller announced recently that he plans to introduce at the next City Council meeting a resolution calling for a restructuring of top level management and a change to the City of Las Vegas Charter.

The resolution, drafted by Councilman Miller, provides for a change in the form of government from the present Council-Manager form to a strong Mayor-Council form of City government. It states that in order "to make for an improved, more democratic, more responsible, more representative form of government and to have adequate time to address and fulfill the mandate of its people, the elective offices of Mayor and City Council should devote their full time and efforts to carry out the wishes of their constituency."

The resolution is also designed "to eliminate conflicts of interest and the costly and inefficient duplication of services and rid the people of burdensome bureaucracy."

The resolution also calls for the elimination of the positions of City Manager,

Assistant City Manager and Deputy City Manager. Councilman Miller explained that these positions would most likely be changed to Assistants to the Mayor and City Council. Since the Mayor and Councilmember positions are currently part-time, the resolution also calls for making the positions full-time with the proper salary adjustments to compensate them for their additional duties. And Councilmembers would be prohibited from engaging in any other outside employment during their term of office. If approved by the City Council, the resolution would have to be adopted by the 1991 Nevada State Legislature.

The next City Council meeting will be held on September 5, in the Las Vegas City Council Chambers, 400 E. Stewart Ave., beginning at 9:00 a.m.
