UNDER A BUSH QUOTA

N'YORK, NY:- In his letter to the editor of The Wall Street Journal, titled "Quota-Free America Is A Costly Illusion," William B. Allen, Commissioner, U.S. Commission on Civil Rights, refutes an earlier editorial page essay by a former Commission staffer, and we quote: "Neal Devins left the staff of the Commission on Civil Rights not long after I joined in 1987. He had been a highly valued employee whose intelligence was missed. He was also very clearly devoted to the goal of ultimate clarity, fairness and universality in our civil-rights laws. In his Oct. 19 editorial-page essay for you on the 1990 Civil Rights Act, however, Mr. Devins provides a faulty analysis. The error involved may cost the U.S. dearly, particularly as it is widely shared by conservatives and the administration. Indeed, now that the president has vetoed the proposal on the grounds suggested, I believe a consequence will be to make civil-rights fairness more remote than ever. The reason for my conclusion, and Mr. Devins' error, is straightforward: The impression has been created that, once the 1990 Civil Rights Act has been vetoed, the U.S. will escape from a quota regime. The reality is that we already live under a quota regime, the 1989 Supreme Court rulings notwithstanding. The administration proposed to codify the 1971 proximate legal cause for the quota regime we have lived with since. Last spring's Supreme Court defense of FCC quotas should make that clear to every intelligence. Yet, what do we hear more often than that conservatives are protecting us from quotas in resisting the 1990 act? It is far worse for America to create the illusion we are quota-free than it would be to dare the folly of quotas and leave our fellow citizens to react. Now, we have no chance to react; we destroy our country little by little, justifying quotas while disguising them under righteous
