tain class of claimants who are eligible for compensation through the recently reauthorized National Vaccine Injury Compensation Program, has been extended to Jan. 31, 1991. according to HHS Secretary Louis W. Sullivan, M.D.

Congress granted the extension because it felt that the previously established filing deadline of Oct. 1, left some would-be petitioners with insufficient time to file a petition.

The program is intended to serve as a faster and less expensive procedure than a civil suit for resolving claims for certain vaccine-related injuries. Using this no-fault system, petitioners do not need to prove that those who manufactured or administered the vaccine were at fault. They must prove that the vaccine is related to their injury.

The federal program provides compensation to individuals who one of the following vaccines: -Diphtheria and tetanus

toxoids and pertussis vaccine (DTP). -Measles, mumps and ru-

bella vaccine. -Oral polio vaccine,

-Inactivated polio vaccine.

The public law that authorized the extension now requires that for injuries based on vaccines administered before Oct. 1, 1988, claimants must now file by Jan. 31, 1991, to use this program. Although claimants may not use the program if they miss this deadline, they still may be able to pursue their claims in civil court

For injuries occurring on or after Oct. 1, 1988, claimants must file within certain time periods prescribed by the National Childhood Injury Act of 1986 as amended.

A claim can be made by any person with a vaccine-related

guardian or trustees. Claimants must file a petition with the U.S. Claims Court, 717 Madison Place N.W., Washington, D.C. 20005. The petition must contain complete medical records and sworn statements to support the claim of a vaccine-related injury.


