## SOME FUNDAMENTAL TEACHINGS **OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS**


**HEAVENLY FATHER is the** ONE AND ONLY SUPREME GOD of our entire universe. He is the Heavenly Father of the Lord Jehovah/Jesus Christ and all spirit persons, of whom each of us is one. He is a loving Father - an Exalted Person, in whose Celestial body likeness and image, man is created.

JESUS CHRIST, known also as JEHOVAH, is a Beloved Spirit Son of God/Heavenly Father. Jesus Christ/Jehovah was designated as GOD OF OUR EARTH by the divine appointment of Heavenly Father. Thus, Jesus Christ/Jehovah became the spiritual father of the kingdom of God on earth (the Church of Jesus Christ/Jehovah), the Messiah, and the Savior of mankind. While residing on earth, Jesus voluntarily suffered

pain and spilled His blood in atoning sacrifice for the sins of all mankind. Jesus set the pattern, and ordinances and covenants, of righteous faith and behavior necessary for an individual to be a worthy member of the Church of Jesus Christ, and to eventually receive eternal life. MAN is composed of two

entities: a spirit person created by Heavenly Father, and a mortal earth body created by earth parents. While our spirit person is joined with our earth body we are a complete person-a soul. The spirit person is the 'heart' (inner person) of man, and has continuity of life after the death of its earth body. During earth life, while the spirit person is bonded with its mortal earth body, the spirit person and the earth body influence each other. They may be harmonious or not harmonious in seeking and following righteousness (God's commandments), or unrighteousness (evil). The free agency of man allows him freedom to choose righteousness or unrighteousness. The choices each of us make determines the state of our spirit person and soul in the hereafter.

When our mortal earth body dies it decomposes into 'dust'. but we (our spirit person) continues to exist. Upon leaving our earth body we enter a temporary residence in the spirit worldeither in Paradise (for the righteous) or Spirit Prison (for the (See Teachings, Page 7)
