

When the news broke that Associated Justice Thorgood Marshall of the United States announced his plans to resign as a member of the United States Supreme Court, the nation suffered a great loss.

Justice Marshall is 83 years old and in recent times has not been in the best of health. Now that Justice Marshall is leaving the court for health reasons President George Bush will be able to nominate to the U.S. Senate a nominee who quite possibly will be the conservative persuasion. If this eventually comes to pass, then there will be a court that Former President Ronald Regan set out to accomplish when he came into office as president.

I first met Justice Marshall in 1947 when he was the chief attorney for the NAACP. He has the distinction of presenting more successful Civil Right cases before the U.S. Supreme court than any other lawyer in history, and an astounding record of winning 43 out of 45 cases presented.

Untold millions of Americans who are poor, helpless, and defenseless, white, Black, Brown and Red have been blessed and helped by Justice Marshall's Vote in the U.S. Supreme Court.

Today Supreme Court Justice Thurgood Marshall announced his retirement, after nearly 25 years on the bench as America's highest-ranking African-American lawyer. Court expert Richard Lazarus comments

"The practical significance," savs Lazarus.


"Justice Marshall is an individual of enormous importance. He is an historic figure. Decades from now it is going to be Justice Marshall, not the other current justices, who will be known by the school children of this country. He embodies the civil rights movement which sought, through the laws, to achieve the most powerful and difficult kind of revolution: chance in human attitude. This

is a great man and his resignation is an opportune time to reflect on his contributions to this country

"The political significance is also undeniable. Between Presidents Reagan and Bush, they will have now appointed five justices, a majority of the Court. Only one justice on the court was appointed by a Democrat: Justice White, who most frequently votes with the more conservative justices. "President Bush and the

Court now face a dilemma: President Bush must feel a tremendous pressure to appoint an African-American to the Court. This is difficult to reconcile with the pressure he also must feel toward many of the interest groups who supported his election. The Court likewise is in a dilemma: The risk being marginal by appearing to be much more conservative than the American public."

Richard Lazarus, who was Assistant to the Solicitor General from 1986-89, has argued 10 cases before the United States Supreme Court.
