The NBA's No.1 draft pick Larry Johnson has finally come to terms with the Charlotte Hornets, team officials said in a Wednesday press conference.

The former UNLV Runnin' Rebel All-American inked a sixyear contract worth a guaranteed \$3.3 million a year through the 1996-97 season, with the first year worth \$1.95 million.

pus Police Tape Rebel Conditioning

David Hollenbeck, the UNLV chief of police, has stated that he was the one responsible for taping the UNLV basketball team's conditioning classes to see if the Rebels had violated NCAA rules by practicing before October 15. However, Hollenbeck said that he was asked only to check on the Rebels, not to film them. Hollenbeck reportedly taped the team for two weeks of the conditioning class, which was headed by UNLV assistant coach Tim Grgurich, at the request of UNLV council Brad Booke.

Booke initially would not

confirm or deny the taping, say- comment on the issue, but against the university. Grgurich ing only that they knew of no major NCAA problems with the Rebel's conditioning class. He later confirmed the taping saying it was an "unusual compliance measure."

UNLV interim athletic director, Dennis Finfrok would not sources have said he did not initiate the idea.

Grgurich, who called the incidents, "outrageous and disgraceful behavior," was hoping for an independent investigation into the tapings, and stated that he is considering filing suit has also claimed that he was tailed by a television station last summer, as well as having his mail screened. He and his attorney, Roy Smith, have yet to file the lawsuit, but Smith said he was studying the issue of whether privacy rights were violated.


