## U.S. DEPARTMENT OF EDUCATION MINORITY SCHOLARSHIP RULING COULD HAVE ADDITIONAL PROHIBITION EFFECTS

Secretary of Education Lamar Alexander's December announcement proposing regulations restricting race-exclusive scholarships may also have the effect of prohibiting colleges and universities from soliciting funds for minority awards.

The Department policy would restrict "race-exclusive" scholarships as a violation of federal Title IV anti-discrimination law. The only exceptions would be when they are used to remedy past discrimination law.

The only exceptions would be when they are used to remedy past discrimination, are created by Congress (i.e., Patricia Robert Harris Scholarships), and are donated through a private foundation or individual, etc.

UNCF has opposed this policy and believes that limiting a ban on scholarships to race is clearly offensive to African-Americans.

The Department did not address gender, national origin, or religious-based scholarships. The College Fund plans to address these issues and the policy itself in our response to the Department's regulations.

Another area of concern is reviewed in a report from the

Chronicle of Higher Education in which the Education Department's General Counsel, Jeffrey Martin, said that the Department, "might prohibit schools from soliciting funds to finance minority scholarships." He stated that the Department's provisions al-

lowing private funding of minority scholarships only applies if the donated money is not solicited.

The Department states the

The Department states the legal components regarding solicitation of funds are still being reviewed and they are request-

ing public comment through the minority scholarship regulations. Yet the regulation issued for minority scholarships does not review solicitation of funds for scholarships. UNCF will closely review and analyze this section of the regulations.
