Soul Music Video, both from their triple-platinum debut on Motown Records, COOLEYHIGHHARMONY. The group will compete with Uptown Records' new find Jodeci and their #1 hit "Forever My Lady" in the Best R&B/Soul Single Group, Band, Duo, R&B/Soul Song of the Year and Best New R&B/Soul Artist categories. Jodeci's album of the same name is also up for R&B/Soul Album of the Year, Group, Band, or Duo.

Also vying for Best New Artist will be Color Me Badd, whose single "I Wanna Sex You Up" from the NEW JACK CITY soundtrack launched the group to the top of the charts. The single also puts them in conten-

tion for Best R&B/Soul Single, Group, Band or Duo and R&B/Soul Song of the Year. CMB will meet head-to-head with Capital artists BeBe & CeCe Winans and their "Addictive Love" single in the latter categories. BeBe & CeCe's DIFFERENT LIFE-STYLE album, certified gold, makes a crossover splash, garnering nods in both the Best Gospel Album and R&B/Soul album of the year, Group, Band or Duo.

Michael Jackson is among a number of artists who received nominations in two categories; he will face off for Best R&B/Soul Single, Male and Best R&B/Soul Music Video with "Black or White." The video category will feature a superstar showdown, the first time Jackson will be pitted head-to-head against Hammer for an award. Hammer's elaborate "To Legit To Quit" video will ironically compete with the technological wizardry of Jackson's Black or White" clip.

Rounding out the field are Patti LaBelle, "Feels Like Another One" for Best R&B/Soul Single, Female; Mariah Carey, EMOTIONS, for R&B/Soul Album of the Year, Female; Will Downing, A DREAM FILLED, for R&B/Soul Album of the Year, male; Guy, THE FUTURE, and Prince and the N.P.G.; DIAMONDS AND PEARLS for R&B/Soul Album of

the Year, Group, Band or Duo; The Geto Boys, WE CAN'T BE STOPPED, Heavy D & The Boyz, PEACEFUL JOURNEY, Naughty By Nature, NAUGHTY BY NATURE, and Public Enemy, APOCALYPSE '91...THE ENEMY STRIKES BLACK, in the Best Rap Album category; Gerald Albright, DREAM COME TRUE, Alex Bugnon, 107 IN THE SHADE, and Fourplay's self-titled album for Best Jazz Album; and Rance Allen, PHE-NOMENON, and Reverend James Cleveland/L.A. Gospel Messengers eponymous release for Best Gospel Album.

All recording artists on R&B, rap, jazz or gospel recordings which charted in any of the leading music trade publications between November 26, 1990 and November 23, 1991 are eligible. Nominees are selected on voting ballots mailed to 3,000 radio station music and program directors and managers or representatives of appropriate retail outlets.

Tribune Entertainment company will syndicate the special for the sixth consecutive year. Tribune also syndicates the long-running weekly "Soul Train" series. Don Cornelius and Anthony Sabatino will serve as coproducers, Ron de Moraes of "Entertainment Tonight" will direct, and George Duke will serve as musical director for the sixth year.
