this case could have wider implications for the general public, especially Black and Latino people. The day after the prisoner rights' ruling, Thomas again aligned himself with the far right of the Court, Scalia and Chief Justice William Rehnquist, in an opinion on allowing the use of Title IX of a 1972 education law to be used in sex discrimination cases.

While the decision was 9-0, Scalia wrote a separate opinion that was signed on to by Thomas and Rehnquist.

They said that the Supreme Court wrongly decided its 1979 case that allowed individuals to sue under Title IX.

They added that since Congress has passed legislation which upheld that decision as the intent of the 1972 law, it was too late to change it all now.

But what the trio did was to lay the basis for overturning the 1979 decision whenever they get a majority for doing so on the

American churches housing registration meetings were bombed or burned by terrorist. In the town of Albany more than a thousand African-Americans were arrested for peaceful demonstrations that began because of the denial of the ballot. Sometime so many were arrested at once that the police station could not hold them. They were herded together outside, on a street that African-Americans named "Freedom Alley."

The county in which Albany is located was typical of 100 counties in eight southern states The essence of Thomas' ra reasoning is that the Constitution ex is a fine document, but its application for minorities and women should be limited. Thomas' w

reasoning reflects the same racism and male supremacy exposed by Sen. Jesse Helms and his ilk. Thomas was not born the

way he is, but like a Judas,

Thomas has accommodated
