qualifications of an AFN described in Mr. Ray Willis' column (3/26/ 92). The pained expressions on her face gave me the impression that it made her seriously ill to have to deal with a person who lived and worked in the Westside area, along with an "I'm in a hurry" attitude coupled with the fact that she practically burned rubber leaving both meeting places. But I disagree with the notion that simple explanations such as, forgetting their blackness or, not caring applies to ALL AFNs. There remains the sixty-four thousand dollar question, Why specifically do AFNs have that snubbing-their-nose attitude?

I, myself, live just a hop, skip and a jump from the Westside. Nevertheless, I am classified as a Westside African American, having taken up residences within the boundaries of Bonanza and Cheyenne, north to south and "A" Street and Rancho Drive, east to west. However, I consider myself an "MAAFN". I have the mental attitude of an After Five Negro even though I do not physically qualify for the category of an AFN.

I was slightly exasperated with some of the "pretty convincing arguments" (in paragraphs 7 and 8) regarding AFNs relocating to the Westside. The percentage of less-well-off persons is far greater than the percentage of better-off persons. The LWO's are the majority, the AFNs are the minority! Therefore, closing the distance between these two factions for the purpose of exchanging free and potentially benefitting information is hardly a sufficient reason; joining the two factions together would hardly stabilize the community; the presence of the AFN minority would hardly raise the value of housing; the Banks, always have, do now, and always will, focus on the impact of the majority; the Westside already has a sufficient number of schools, enough to serve the entire community; there are already numerous franchises and businesses to service the Westside community in its various needs, and there are enough neighborhood markets and convenience stores - all in close proximity of each other-to serve in the capacity of a Supermarket that could surpass Smiths, Vons, Lucky and Albertsons. So what's the problem with these arguments? Majority Rules!

AFNs do not have to "live" among LWOs in order to exchange free and beneficial information; if LWOs want the AFNs in their community then the LWOs ought to change their attitudes and standard of living; to raise the value of housing. LWOs must take pride in themselves and their community, take care of their property and clean up the trash! If AFNs out-numbered the LWOs (became the majority) in the community then the Banks would indeed be interested; improve the quality of education and upgrade the facilities and grounds of the schools already existing; and patronizing the already existing franchises and businesses will enable them expand, thus contributing to the growth of the community.

I am an AFN at heart, not because I don't care, or because I don't want to be black. But if given the opportunity, I would readily move into the physical category of an AFN. Crime seems to be more prevalent in the Westside (with North running second) than in the South and East sides. What AFN wants their home burglarized and their hard-earned possessions taken, damaged, or totally destroyed? What AFN wants to enroll their child or children in a school where various other atrocities and tragedies can easily occur? What AFNs want themselves or family to live in constant fear of becoming the victim if a drive-by shooting, gang war or homicide of any nature for

cashed by anyone except the recipient named on the money order. (It's important to immediately sign the money order and fill in the state or federal government payee.)

•RECORD RETENTION — If a money order is lost, it's possible to trace and replace it using the number imprinted on the receipt. Just as important, processed original copies are stored on microfilm for seven years, providing a reliable personal or auditor record.

 CONVENIENCE — Money orders are sold in grocery stores, pharmacies, convenience stores, check cashiers, financial institutions and, in some states, liquor stores.

Money orders are convenient, inexpensive, and have been a reliable form of payment for more than 100 years. In fact, they've been around almost as long as Americans have been paying income tax.

On Thursday evening, Dr. Ben returned to New Jerusalem Missionary Baptist Church's Addison Community Hall where he narrated several series of slides from his collection to the nearly 100 persons who returned on day two of his lecture.

Dr. Ben said that he has nearly 25,000 slides in his total collection and that at 73 years of age he can still remember what is taking place on each slide.

Even if you had some disagreement with some of the information that Dr. Ben delivered, you were culturally enriched by the masterful, scholarly approach that he took in presenting his material.
