

# SHANNON REEVES NAMED TO HEAD THE NAACP'S WEST COAST OFFICE

Shannon F. Reeves has been appointed Director of the NAACP's West Coast Region I, effective February 3, 1992, Dr. Benjamin L. Hooks, the Association's Executive Director/CEO has announced.

Mr. Reeves, a graduate of Grambling State University, has served the NAACP in a number of capacities including membership of the National Board of Directors and Northern Area Youth President. At 23, Mr. Reeves is the youngest Regional Director ever appointed in the 83-year history of the NAACP.

"My appointment as Regional Director attests to the positive training provided through my involvement with the NAACP. I came

up through the Youth Council and the ACT-SO Program to become a state youth president and a national board member, and now I hold a major position," he said.

While at Grambling State, Mr. Revees activated the college's NAACP chapter and served as president. He also ran for Mayor of Grambling, Louisiana, losing by only 20 votes.

In addition to his work with the NAACP, Mr. Reeves has held a number of other positions including Ombudsman and Special Assistant to the President of Grambling and Field Representative and special assistant to Rev. Mr. Reeves also worked as a summer intern in the Office of the Mayor of Oakland, California in 1985.
