

DEMOCRATIC PARTY OF NEVADA TO CONVENE

The Democratic Party of Nevada will convene their statewide meeting at 9:00 a.m. on Saturday, May 2, 1992, at the Tropicana Hotel in Las Vegas. Registration will be available for delegates on Friday from 4:00 p.m. to 9:00 p.m. and on Saturday from 7:00 a.m. to 12:00 noon. Representatives from all 14 counties in Nevada are scheduled to attend.

Prominent Democrats as featured speakers include Congressman James Bilbray, Mayor Jan Laverty Jones, Senator Richard

Bryan, Attorney General Frankie Sue Del Papa, Governor Bob Miller and Senator Harry Reid.

Messages from Presidential candidates will be interspersed throughout the convention. The "marathon" event will go straight through the convention process, with a recess at 2:00 p.m. for presidential caucus meetings to select representatives to the national convention in New York City in July. The election of the "at-large" delegates is scheduled for 4:00 p.m.

Nominations for State Chair are scheduled for 11:00 a.m., with election for this leadership role at 1:00 p.m. Beverly Carlino and Richard Segerblom are announced candidates. At 5:00 p.m., the schedule calls for elections of State Party officers and a second ballot for the First Chair, Second Chair, Secretary and Treasurer.

Committee meetings will commence Friday afternoon, and be scheduled right up until the close of the convention Saturday evening.

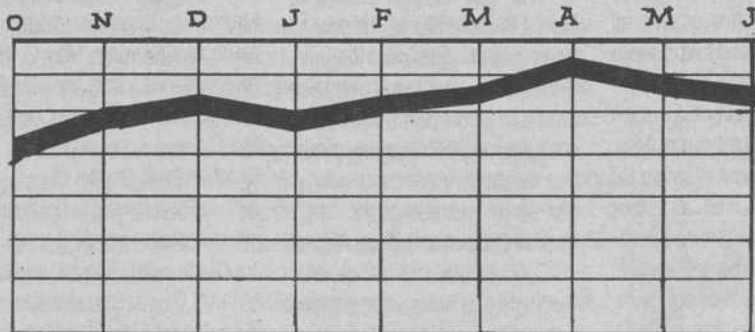
