state and federal civilian control over the police departments. The results of this case concerning the officers' brutal beating of Rodney King is sufficient proof that oversight and review of the actions of police is inadequate.

Civilian control of police would include the establishment of civilian control boards that would have full investigative powers over the police, including subpoena powers and as such would serve as a deterrent to police crimes.

Now is the time to bring even more people to the May 16 Save Our Cities, Save Our Children march and rally in Washington, D.C. It provides an opportunity for people to bring their demands for justice for Rodney King directly to the White House and Congress.

Additionally, the demands made by organizers and endorsers of that action, starting with transferring funds from the Pentagon to people's needs, are in line with what people are saying to improve their standard of living and restore hope to the urban centers.

And let us not forget Bush. His response not only accelerates the importance of civilian control of the police and putting justice into the criminal justice system, but it raises the stakes of who we, the people, want elected in the 1992 presidential, Congressional, state legislative, gubernatorial and municipal election.
