1. NOTICE IS HEREBY GIVEN that the Housing Authority of the City of North Las Vegas will receive bids for the furnishing of all labor, materials, and services for the CIAP Project NV 7-907 MODERNIZATION BID PACKAGE "A" AND CIAP Project NV 7-907 MODERNIZATION BID PACKAGE "B".

2. Work in Bid Package "A" includes, but is not limited to, foundation repairs at Rose Garden, replacement of damaged gutter and downspouts, replacement of incandescent bath lights, and renovation of existing storage area at Casa Rosa. Work in Bid Package "B" includes, but is not limited to, construction of new trash enclosure, addition of existing CMU wall, alert alarm system at Rose Garden, and additional smoke detectors at Casa Rosa.

3. 5. A prebid conference will be held on August 13, 1992 at 3:00 PM local time in the Rose Garden Senior Recreation Hall, 1632 Yale Street, North Las Vegas, Nevada. All prospective bidders are urged to attend. Non-attendance on the part of the bidder shall not relieve the bidder of any responsibility for adherence to any of the provisions of this bid package or any addenda thereto.

6. All responsive bids will meet the requirements established in the contract documents under "Instructions to Bidders". Each bid shall be accompanied by a certified check, bank draft or a satisfactory bid bond executed by the bidder in an amount equal to five percent (5%) of the bid, made payable to the Housing Authority of the City of North Las Vegas.

7. Responsive bids shall contain Certification on Equal Employment Opportunity required by Section 3 of the Housing and Urban Development Act of 1968, amended 1969, and further amended by Section 118 of Title 1, Community Development and Housing Act of 1974, and Executive Order 11478. (These requirements are contained in the bid documents.) The target date for purposes of Section 3 compliance is as work commences.

8. Bidders shall submit a complete list of any subcontractors to be used on the project.

9. HUD Form 2530, Previous Participation Certificate, must be completed and submitted within three (3) calendar days of bid acceptance.

10. All bids must be submitted in a sealed envelope, plainly marked "CIAP Project NV 7-907 MODERNIZATION BID PACKAGE "A" or "CIAP Project NV 7-907 MODERNIZATION BID PACKAGE "B". Bid submittals must also specify whether they are for Bid Package "A" or Bid Package "B". Those submitting bids for both Bid Package "A" and Bid Package "B" are advised that the time for completion listed in the contract documents shall run concurrently and not consecutively. The successful bidder will be required to furnish and pay for a Performance and Payment Bond from a U.S. Government approved surety, per Treasury Department Circular 570, current revision, as well as evidence of current personal injury, property liability, workman's compensation, and builder's risk insurance.

13. Contracts will be awarded to the lowest responsible bidder not on HUD's list of ineligible contractors, provided that the bid is reasonable, in the best interest of the Housing Authority, and provided that the bidder has complied with all applicable laws. The Housing Authority of the City of North Las Vegas reserves the right to accept alternate bids in any order it chooses, to reject any and all bids, and to waive any informality in bids whenever it is in the best interest of the Housing Authority to do so.
