ORGANIZING AND WINING

When the Las Vegas branch of the National Alliance Against Racist and Political Repression holds its Freedom Award Banquet on September 5th at the Moulin Rouge it will be an occasion for celebration of many things, not the least of which will be the fact that the petition campaign requiring the 17,600 signatures to place the issue of civilian control of the police on the ballot in November has been successful.

At this point we are in the excess of 18,000 signatures and

though the campaign will continue through September, the purpose of the continuation at this point is to merely cushion ourselves with an excess number of signatures in case the State decides to play games and invalidates a certain percentage of the signatures. I project that somewhere between twenty-five and twenty-seven thousand signatures will finally be turned in to the Secretary of State's office. This victory in terms of getting this issue on the ballot in November comes about through the concerted efforts of many

people. The news media would have you at times believe that only one or two people have been involved. However, clearly twenty-thousand signatures cannot be gathered by one or two, or even five or six people over a six month period of time, which is what the organization had to do according to State guidelines.

The second victory that will be celebrated will be the fact that many organizations, other than the Alliance, have participated in this effort. And while it is clearly not the end of the story, it does appear that we are well on the road to civilian control of the police in Las Vegas. What will

be necessary will be that there be continued organization to get out the vote in November as well as continued opposition to the disinformation that the Metropolitan Police Department is now, purposely spreading.

We have known for some time that Metro would—if the issue appeared to be headed toward being placed on the ballot—begin to up the ante by a smear campaign in the media at every opportunity. We have seen that the number of "Officer Friendly" commercials that appear on local Channel 5, a Fox affiliate, has increased. Look for it to escalate even more as the police try to convince the citi-

zens of Clark County that they are indeed humane.

Unfortunately for Metro the citizens of Clark County have had adequate experience with their organization to understand what they do and just how "humane" they are.


The Metropolitan Police Department should understand that their antics in terms of attempting the intimidation of signature gatherers by forcefully taking petitions away from people and the various other little dirty tricks have not worked and that there will be civilian control of the police in this State. It is that, that we celebrate on September 5th.

SEEING GOD IN US

What difference does it make what color or race you think the Supreme Being (God) is? According to mental health experts, it can mean a lot—especially if you're an African-American.

They say it is important that your image of God in human form look similar to you. Because if you can't perceive God in your own image, you will find it difficult if not impossible to think very highly and self respecting of yourself and others who resemble you.

If someone asked you to describe what God looks like, how would you respond? What physical description of God would you provide? How would you envision Him? Would you say that He is white, black, red, brown or yellow?

The standard picture of Jesus, God's son, that we often see in churches portray Christ as having thin lips, alabaster white skin, rosy cheeks and long, flowing straight hair. But rarely, if ever, do you see pictures of a Black Jesus.

It's not documented anywhere in the Bible or elsewhere that Christ was White. Yet that almost singular concept of the savior is seldom challenged. Many find it easier to simply accept the prevalent view of Jesus as white or nearly white.

Given the fact that Christ lived in that region of the world now known as the Middle East, it's probable that he was of a darker complexion. Remember those images from Iraq of Middle Eastern men and women who looked remarkably like Black people we know right here in the U.S.?

And where is the Middle East? Smack dab on the northern tip of Africa—The Motherland.

With a resurgence of interest in Black awareness some progressive Black church leaders are beginning to display stain glass murals and pictures of Christ as a Black man with distinctly Black features.

Such displays make a definite positive statement by allowing that Christ was probably of African descent like us.

Since nine-tenths or more of the people on planet earth are people of color, it stands to reason that Jesus also was of color. The fact that the oldest remains of mortal man were unearthed in that portion of African Bible scholars refer to as Mesopotamia, adds weight to the argument.

That God in all His splendor and glory is reflected in our own image makes a significant, positive psychological statement to all Black people. Because if we can't see God as a reflection of us, then (See Ray Willis, Page 17)
