The classes will be held the last Saturday of every month, thereafter. The classes will be held at the Chamber office on W. Owens from 9:00 -4:00 p.m. The cost of the course is \$18.00 for Chamber members and \$24.00 for the general

A Standard First Aid card and an American Heart Association CPR card will be issued to each participant at the completion of the course.

Emanuel Wasson, III, Operations Manager of the Nevada Black Chamber of Commerce, stated that he felt this course is very pertinent to the Black

community since some 45 percent of Black Americans suffer from some form of hypertension.

The course will cover information on rescue breathing, choking, and CPR. In addition, the class will cover the Signs, Symptoms, and Recognized First Aid Treatment for: Allergies, Bleeding, Burns, Bites, Diabetic Emergencies, Eye Injuries, Fractures, Heart Attack, Heat and Cold Emergencies, Poisoning, Seizures, and much more.

Kenneth Glover stated that he and his company would like to work with the Black community to teach as many people as possible Basic Life Support CPR. "With just the recent drownings in the Las Vegas area, we see the need for the course," he said.
