Fortunately I was there to correct that ignorances statement for my child, but other children suffer from statements like this on a daily basis. This type of statement becomes damaing to a child because of the obvious. It is the type of statement that tears to the core of a child's inner pride and makes the child feel abandoned by his parents interests,

whether it is true in the child's

personal life or not.

I am certainly not saying that all white teachers are a part of this conspiracy, but I am saying that if we as African American parents want the best for our children we must keep a watchful eye on the reality of the situation. As many of us know the conspiracy is for the most part, difficult to detect, ranging from the obvious to the less obvious. We must understand that our children are helpless in a world that even our historical achievements are denied.

The school systems should set up classes and seminars to help the European American educators become more sensitive to the needs of African American children. There are a number of Black psychologists and programs available to teach these teachers how to teach and become effective in the schools. These classes will ensure that the European American teachers would not bring their racist conceptions into the classrooms. They would show the educators that African American children have a great deal to offer, they may teach these educators how to respect our children, and they would learn that different cultures should be accepted and

If we solve the problems of our Black boys in school we may eliminate the problems for future

Black men. Frances Welsing wrote that, Racism is viewed as a global behavior power system with a constant and specific set of power relationships. Racism evolved with a singular goal of white supremacy or white power domination by the global white minority over the vast non-white global majority.

Racism, whether consciously or unconsciously, evolved as a survival necessity for the global white minority. Whether consciously or unconsciously it is taking place in our school sys-

tems, by administrators as well as by teachers. These educators should be made to realize that they are being entrusted with our most valuable source and the key to our future.
