"MURDER IN MISSISSIPPI"

This extraordinary investigative documentary reveals new evidence, nearly a quarter of a century after the events occurred, about the murder of three young civil rights workers in Mississippi, in a crime that made headlines around the world. James Chaney, Andrew Goodman, and Micheal

Schwerner were traveling south from Oxford, Ohio in 1964. On their way to Meridian, Mississippi, they were picked up by the State Patrol then released the following evening into the hands of their murders. half of the standard fares, making the straight cash reduced fare .50. Disabled persons are eligible for the reduced fare and children under five ride free when accompanied by fare-paying adult.

One of the major features of the new system will be free transfers. Passengers will be able to transfer from bus to bus at major intersections. Buses will run on virtually all major Las Vegas streets.

attract the curiosity of tourists and locals alike, and will be a permanent monument for Las Vegas residents.

Ms. Duncan said that she was encouraged by Luberther Johnson and others to include a visit the Moulin Rouge Hotel & Casino as part of the new "Black Cultural Tour," along with other attractions.

In addition to the new CAT system, federal law requires the RTC to operate an expanded Paratransit system for the handicapped, a system now operated by E.O.B. (Economic Opportunity Board of Clark County.) However, RTC must now put up the Paratransit system for open bidding, thereby putting E.O.B. in competition with other bus service operators for the new contract.

The new Paratransit system will receive 17 additional buses.

Also, under the new CAT system, Las Vegas Strip Service will be 24 hours, a benefit to both tourists and residents.

At the Downtown Transportation Center, passengers waiting for an Express Strip bus were glad to hear about the new expanded bus system.

"I have been coming to Las Vegas for 15 years," said a tourist from Chicago, "and I could never figure out why the service was so bad."

An African-American man sighed and said, "Finally it will be easier for me to get to work. Right now, it is a mess!"
