

Not long ago "60 Minutes" carried a compelling story about people with hemophilia who were succumbing to AIDS in alarming numbers as a result of their unknowing use of tainted blood products.

The terrible plight of these victims is enough to get you right in the gut. But there's more. The rest of the report about them focused on how destitute their families were becoming due to the high cost of their medical treatment once they got AIDS.

But the part of this report that really caught my attention was when they discussed how many of these victims were being forced onto the public dole just like welfare mothers. Even worse, the report said, they were discovering in the process for the first time how unfair the welfare system is—especially for married couples. Many of these couples have been forced to consider getting a divorce against their will in order to qualify for welfare benefits.

As these unfortunate souls spoke to "60 Minutes" you could see them express utter disbelief, even disdain for the welfare system. Thinking out loud collectively they were saying, "How could a nation as great as America force decent families to separate in the name of receiving public aid? How could this country do such a dastardly thing to God-fearing, law-abiding, upstanding citizens?"

The answer to their questions is incredibly simple. The same standard that applies to these luckless individuals and families is the same standard that applies to welfare mothers everywhere. One main welfare axiom in 1992 is that you can't qualify for welfare with a man in the house. And government social workers constantly spy on people to make certain they don't try to trick the system.

Welfare, as we now know it, was developed during the depression-era in the '30s. Back then, though, it was a more acceptable and positive form of public assistance. White families were encouraged to accept welfare until the male head of household could get back on his feet. Later on, when the economy got better and jobs were plentiful for White males, the welfare system started to change many say for the worse. No longer does the system allow a male head of household to remain in the home. This was the precursor to the nonsensical system we now have.

As I listened to the "60 Minutes" broadcast repeatedly belabor the plight of the families of these AIDS victims, I asked myself, "is there something wrong with this report? If so, what?"

And then it dawned on me that neither the reporter nor the victims and their families seemed to grasp what was happening. For decades people on welfare have complained that the system was unfair and needed to be changed. Obviously, their complaints fell on deaf ears. The same welfare requirements that everyone else has to live with, are the same ones they must now rely on to relieve their own destitute status.

It's a sad but deadly accurate commentary that many people don't have the appetite to pay close attention to how "unfair" the welfare system is until or unless they need it for themselves.
