LVABSE MAKES A LAWSUIT STATEMENT UPDATE

In its recent "News Update"
Summer 1992 issue, the Las
Vegas Alliance of Black School
Educators (LVABSE) made the
following lawsuit statement to
update its members, volunteers,
and supporters.

In the midst of a possible renewal of WAAK-UP's boycott against the Clark County School District recently, Marzette Lewis, President of WAAK-UP, wanted let readers know know that the LVABSE lawsuit had nothing to do with their efforts. Lewis stated that WAAK-UP began after her son was molested on a Clark County School District bus, and after fruitless efforts to get some action she decided to go public and get

other parents involved in getting resolutions to problems plaguing parents and school children. The school district had alleged that there was a conspiracy between WAAK-UP and LV-ABSE and in fact, each organization just recently, became aware of each others efforts.

The following statement was acquired by the SENTINEL-

VOICE to give readers a status report on the recent Class Action Lawsuit filed by LVABSE.

The Las Vegas Alliance of Black School Educators (LV-ABSE), joining eight Black parents and 13 Black students filed a lawsuit with the Federal District Court charging Clark County School District's Board of Trustees and Superintendent Brian Cram with system wide racial discrimination and segregation.

When the Board of Trustees purged the school district of virtually all its top ranking Black administrators in the spring of 1989, the Alliance filed papers (lawsuit) in Federal District Court. On Tuesday, February 20, 1990 the papers were revised from the initial May 1989 filing, which substantially expanded the issues to be tried in Federal District Court.

Specifically, the revised complaint submitted in February 1990 contends that the Board of Trustees and its Superintendent have taken the following racially discriminatory actions to create and maintain system-wide racial segregation designed to benefit white students by placing the primary burden on Black students:

 Manipulating school attendance zones and feeder patterns to make student enrollments racially segregated;

 Choosing sites for school construction and additions in a manner which increases racial segregation;

 Deliberately utilizing grade structures which create or maintain racial segregation;

 Practicing racial discrimination in hiring, assigning, promoting and demoting administrators, teachers and school support staff; and

5) Failing or refusing to develop or select classroom textbooks and the curricula material which accurately reflect the role played by Blacks in this country.

The plaintiffs prevailed in Federal Court when the case

was certified as a Class Action Lawsuit, representing more than 17,000 Black students in Clark County, Nevada. However, on October 31, 1991, the lawsuit was dismissed by Judge Lloyd George for summary judgement filed by the Clark County School District. On November 1, 1991,
