is somewhat lax in his duty in that he has remained strangely silent. It is known that he is a favorite, and an advocate of law enforcement. That, to us, seems to be a personal problem. He is also, however, by way of his job description, Governor of all the people in the State of Nevada.

It would then seem unconscionable to ignore such a raging battle going on in his most populist state. Many politicians believe that voters have a very short memory.

Perhaps that is true, but we as citizens of Clark County should remind the Governor that our memory ability can very easily be improved upon, especially two years from now when it is time for Big Bob to take the big plunge again.

The recent debacle on the part of those "mental giants" at the Secretary of State's office, which by the way is a part of the Governor's administration, shows the level at which the state operates.
