manager for Nevada Business Services said: "NBS is now attempting to locate those specific direct employment placement. individuals who qualify under the Dislocated Worker Project. In addition, two counselors have been hired by NBS to work specifically with those who qualify for this particular program."

Murphy indicated that at the

present time, the Dislocated Worker Project is located at 820 Shadow Lane, Suite #206, Las Vegas, Nevada and that NBS is attempting to locate office space for this program in the impacted area if at all possible.

Councilman Hawkins outlined the client eligibility as fol-

- Those individuals who lost their jobs due to the civil unrest who were working for businesses located in the target area.
- · Those individuals who lost their jobs due to the civil unrest, but not directly located in the target area.
- Long term unemployed applicants for the target area.

Mr. Murphy then explained the options available for either Mr. Bill Murphy, operations employment or training:

Employment-

- · NBS will assist trainees in an authorized "On the Job" training program of up to 40% of the wages for a minimum of six (6) weeks, and requires completion by 12-28-92.
 - · NBS will assist trainees in

temporary employment of 100% of salary, paid out of the title III-E grant funding. (Approved temporary employment can be authorized for "public non-profit" organizations such as the "Boys & Girls Clubs," or other community based organizations.)

Classroom Training-

 NBS will assist trainees in short term classroom training which must be completed by 12-1-92 in order to have the client employed under the criteria.

· NBS will authorize eligible non-profit community based organizations that are capable of training trainees; i.e... Chamber of Commerce, The Latin Chamber of Commerce and the City Task Force, ETC.


