If there was a weakness in the news report it was that the authority source used later on in the segment to respond to questions about police tactics was none other than brand-new Los Angeles Police Chief Willie Williams, himself a Black man. In my view, a Black man is not the best spokesman to respond to a racial issue about Black men when the audience is not Black.

At one point while being interviewed, Williams was asked what can be done to prevent Black men from being illegally detained. He responded by talking about sensitivity training and so forth. Of course Williams was responding like any self-respecting top law enforcement official who happens to be Black would. But he totally misses, or at least skillfully avoids, the real point.

How can a Black man, a victim of racism himself, be a believable spokesman in this instance? He can't change the dynamics of racism. Until or unless racism is eliminated, 20-20 and all the other TV news shows in the world can do nonstop daily news reports about Black men being harassed by the police and conditions will not change. Keep everything clearly in perspective. As long as Black men are treated untairly we must view news reports like this one as simply a reflection of the society in which we live. Further, the different treatment Black men receive from the police and society in general is a predictable by-product of the dehumanization of our race. Putting an end to racism is the only way to end unwarranted cop stops.

NATIONAL ALLIANCE AGAINST RACIST & POLITICAL REPRESSION

On Monday, November 9, 1992 at 10 O'clock a.m. in the court room of Municipal Court Judge Barlow, the charges against Doctor James S. Tate and the National Alliance Against Racist and Political Repression, stemming out of an arrest performed by the Nevada Highway Patrol at the Department of Motor Vehicles on June 27, 1992, were dismissed. The dismissal verifies what has been maintained by the Alliance all along, that the City and the State, in collusion with each other, attempted to

concoct a purely politically motivated criminal case in order to derail the effort at securing civilian control of the Metropolitan Police Department. Indeed in his dismissal, Judge Barlow indicated that even reading the documents submitted as the indicting documents by the City, there was no indication of any criminal activity. In other words, the City of Las Vegas never had a case and does not have a case now, and so the charges were dismissed. It is indeed unfortunate that Judge Barlow dis-

the charges without prejudice, which allows the City to re-file the charges within the next year and one day. In other words, the Judge was in essence telling the City that you don't have a case now, you didn't have a case before, but you have a year and a day to make one up.

What in essence this does, is allow the City to now go back and get it's lie together. The City Attorney whose competence is clearly shown by this dismissal,
