CLINTON AND THE COURTS

When Bill Clinton becomes jupresident next January he will have a plate full of decisions to make, many of which, such as a national health program, job creation efforts, and comprehensive job training programs, will shape our national life for years to come.

But long term, among the most important and lasting effects of his Administration will not come in the first hundred days but will evolve over the course of his term.

That is the effect the Admini-

stration will have on the federa judiciary.

As president, Bill Clinton will become the first Democrat in a generation to appoint Supreme Court justices and to have a significant opportunity to reshape the federal judiciary. Thurgood Marshall was the last Supreme Court nominee of a Democratic President.

Since Lyndon Johnson's presidency, every High Court appointment has been made by Nixon, Reagan or Bush.

As a result, we have the most ideological Court in memory,

seemingly dedicated to pushing an activist conservative philosophy that devalues civil rights and individual privacy.

It is a Court that has progressively weakened the impact of civil rights laws and undermined the effectiveness of affirmative action and set-aside programs.

Recent decisions have made it more difficult for poor women to choose to have abortions, weakened local anti-bias laws, and undermined local government attempts to help minority businesses.

Any single one of the Court's

decisions might be rationalized as correct under traditional standards of constitutional law, but taken together, the Court's record in recent years suggests a definite trend toward eroding long-established rights.

One sign of how conservative the Court has become is the way justices formerly thought of as conservative are now labeled liberal in the context of today's Court.

That not only tells us how meaningless such labels are, but also how Justices Rehnquist, Scalia, and Thomas have staked out extremist positions that pushed the Court rightward.

Observers predict that the Clinton Administration is likely to have several opportunities to fill vacancies on the Court.

Most often mentioned as possible retirees, however, are Justices identified with the moderate wing.

The Court's far right line-up is younger, and will be with us for many years to come. That places an even greater responsibility on the new president to appoint Justices who will ensure that the Court does not tip over to an activist conservative majority. Now, only one vote is enough to destroy established privacy and civil rights.

But the Supreme Court is not the only federal legal institution in need of appointees more in tune with the modern world and with the nation's needs.

There are 846 federal judges, all serving for life. Almost two-thirds of them were appointed in

the Reagan-Bushyears, and had to pass the litmus test of a restrictive view of what federal courts could do to protect individual rights.

Those judicial individual rights.

Those judicial appointees of the 1980s were almost exclusively white males. President Jimmy Carter made a determined effort to place African Americans, women, and minorities on the federal bench, but his successors have kept the judiciary a white male preserve.

We can expect a Clinton Administration to remedy that with appointments that reflect the full diversity of the nation. And we can expect Clinton's judicial appointees to be committed to preserving the civil and personal rights embedded in our traditions and our constitution.
