McCall and Hoggard reclassified as pre-kindergarten through fifth grade schools as stated in their West Las Vegas Prime 6 proposal.

These schools will provide educational programs to develop appropriate education for students in pre-K through grade five. The program will be consistent with the school district's educational principles and the elements of quality, with a planning team at each school consisting of the principal, staff, parents, and community representitives. The planning team shall develop the focus for the school, based on the needs of the students. The curriculum and instructional strategies will be based on principles and practices established by the Nevada State Course of Study and Clark County School District Curriculum Essentials Framework.

Retired attorney, now activist, Barbara Robinson said studies have shown that African American children in the early grades (1-3) score well above other kids, until the fourth grade. The reason is unknown, but African American children are said to be vulnerable at the fourth grade level. She says, it is better for them to feel comfortable at this stage rather than allowing them to be susceptible to the changes of being bused from one school to another.
