bent, agreed change was necessary. "We need trained leaders in the organization," said Rev. Scott. "On Feb. 13, members from the L.A. office will conduct leadership training here."

In addition, Scott said the local chapter needed an attorney on retainer and should institute a dues and donation check-off plan with local employers.

Wesley-Lee said that the NAACP has been "in slow motion" and she would draft plans to bring about change.

Goynes emphasized his youth. "I am young and strong," he said. Goynes said he felt the chapter needed more sophisticated measures other than marches and demonstrations. Wesley-Lee added that the chapter should work with other organizations. Wesley-Lee is a member of WAAK-UP which successfully lobbied to overturn the Clark County School District busing plan which black parents said worked against their children.

Rev. Scott clearly showed that age had not dimmed his vision or passion. "Just look at Poland and West Germany. They are marching," he said.

But despite Goynes' criticism of the older incumbent president, the younger candidate took the time to acknowledge Scott's work. "He (Rev. Scott) has been a soldier for civil rights," said Goynes. "He was there when we were sometimes not there for ourselves."

Goynes' remarks about Rev. Scott drew the longest and strongest applause of the evening.

KCEP's Troutman asked one of the most important questions raised during the debate: Were you pleased with how the

NAACP handled the Charles Bush case?

In response to the Bush question, the demure Wesley-Lee unleashed her fire.

"I was in court everyday," said Wesley-Lee, "and you could count the number of blacks there on one hand. We were not there."

Goynes said that he would have pulled in legal counsel from other chapters to help out the local chapter.

The feisty, 70-year old Rev. Scott then snapped back. "The case is not over. We did not drop it. We just need money to go back into court."

All of the candidates criticized the local white press for its constant negative portrayal of West Las Vegas. And the candidates also agreed that the community had to support the NAACP with both dollars and volunteer work in order for the organization to improve conditions for black people and for West Las Vegas.

When a member of the audience asked about low employment of blacks in stores with a high number of black customers, Rev. Scott answered that "economic withdrawal" was the answer.

Both Wesley-Lee and Goynes agreed with Scott and said that blacks should be able to shop in their own neighborhoods and that West Las Vegas needed more stores. Wesley-Lee said she was currently involved in the effort to bring a major shopping center to the community.

The debate was attended by more than 100 people varying in age and occupations. Debate organizers and candidates were pleased with the turnout.

The NAACP election is only open to current, paid-up members of the Las Vegas chapter (See Election, Page 16)
