## RAY ASSIGNS LAS VEGAS STAFFER IN WASHINGTON, D.C.

Congressman James Bilbray today announced he is assigning long-time staff member Franklin Simpson to his Washington, D.C. office for the upcoming 103rd Congress.

Congressman Bilbray has high praise for Mr. Simpson, "For years Franklin has served me well in the District Office, involving himself in the areas of Small Business and Immigration. I now feel his experience and knowledge of the Las Vegas area will best serve the citizens of Nevada from an office on Capital Hill."

Mr. Simpson has also served as a liaison for Congressman Bilbray to the West Las Vegas community. He represents the Con-

gressman on the boards of the Nevada Minority Purchasing Committee, the Multijuristictional Community Empowerment Commission, and the Las Vegas Martin Luther King Committee. The Reverend Marion Bennett, who believes a piece of property he owns is worth more than the value set by an independent appraiser for the city, held a press conference Tuesday at the West Las Vegas Library to air his complaints.

Bennett, flanked by his daughter, Attorney Karen P. Bennett, and representatives from the National Alliance Against Racist and Political Repression, said he believes the \$1.75 per square foot appraisal by the city was unacceptable, especially since the city appraisal for an adjacent parcel owned by Donald Goetting, a white man, was \$2.25 per square foot.

The land in question is three acres Bennett owns at the corner of "H" and Owens, that the City's Redevelopment Agency needs to build a 22-acre shopping center project, which was planned earlier this year. Bennett's property and two others are the remaining pieces of land needed for the 180,000 square-foot shopping center, which once completed, will house the area's only major grocery store. The city also says the multi-million dollar project

should create close to 200 new

Karen Bennett, however, stated that the city has other property in the area that is equally suitable for the project, and that they should focus more on assisting existing Black busi-


In a letter to Rev. Bennett, sent last month by William Noonan, Executive Director of the City of Las Vegas Downtown Redevelopment Agency, the city said that the redevelopment of Bennett's land would, "help to eliminate environmental deficiencies and blight (deterioration) within the Redevelopment Area and provide for needed site improvements designed to stimulate new commercial expansion, employment and economic growth within the Redevelopment Area."

In response, Atty. Bennett wrote back to Noonan stating, "The question of whether Rev. Bennett's property can be deemed 'blighted' is a legal question which ultimately may have to be resolved through liti-

In addition, Bennett's letter said, "This presumption is very much indicative of your total disregard for the rights of African-American landowners in West Las Vegas."

"This is just one of many efforts the city is making to depreciate the value of the land," added Atty. Bennett at the news conference.

Noonan stated that the initial appraisal on Bennett's land was only the first step in the negotiation process, and that the city



has offered to let Bennett pick another appraiser to judge the value of the land. In addition, Noonan said the higher appraisal for Goetting's properties could be due to the fact that the vacant lot, once a sports bar, has an active liquor and gaming license, which would add to its value.

The redevelopment project came as a direct result of the April unrest that followed the acquittals of the four white Los Angeles police officers in the Rodney King case.

Bennett has stated that he refuses to be pressured into accepting any offers that he feels are unfair

Southern Nevada, and the University of Nevada-Las Vegas where he is a member of Alpha Phi Alpha Fraternity. Mr. Simpson also serves in the U.S. Army Reserve Medical Corps. Mr. Simpson will transfer to Washington, D.C. before the end of the year.

He will continue to assist the Congressman in the area of Small Business, possibly working with the staff of the House of Representatives Small Business Committee
