REID TAPS HERBERT BROWN FOR MARSHALL POST



WASHINGTON — U.S. Senator Harry Reid recently nominated a 21-year veteran of the North Las Vegas Police Department for the post of United States marshall in Nevada.

Herbert L. Brown, 51, served as Assistant Chief of Police for the City of North Las Vegas since last year. He recently retired from that position. From 1987 to 1992, Brown was Director of Community Relations/Crime Prevention Bureau of the City of North Las Vegas Police Department.

From 1971 to 1987, Brown worked for the North Las Vegas Police Department in many capacities including Field Training Officer, Juvenile Detail Investigator, Covert Surveillance Detail, Traffic Accident Investigator, and Patrol Officer.

Brown has been trained in police work by the Federal Bureau of

Investigations, U.S. Department of Justice, Drug Enforcement Administration, and the Nevada Peace Officers Standards and Training in Carson City. He is also a member of the International Association of Chiefs of Police and the International Union for Police Associations.

Reid said Brown has the experience and character needed for the Marshall's job, "Herbert Brown has worked in every level of law enforcement," Reid said. "He has earned the respect and appreciation of his colleagues and the community. Herbert Brown will be an outstanding U.S. Marshall."

Reid submitted Brown's name to the Administration. Upon Senate approval, President Clinton will appoint Brown to the Marshall's post.
