Eleven weeks into the 67th Session of the Nevada State Legislature most Assembly and Senate representatives are hard at work. Attempting to balance the fiscal budget and prioritize state program funding is no easy job. Governor Miller is riding everyone's back to reorganize state spending and solve the SIIS disaster. Last week the governor told the Legislature to get to work because only 6 1/2 weeks were left before a special legislative session will have to be called.


