Recently, legislators have introduced innovative ways to meet the concerns of their constituents and deal with issues that would otherwise be ignored. As a legislative intern, I have been able to put into perspective how introduced legislation will affect our community either positively or negatively.

Here are some newly introduced legislation and issues facing the legislature in the coming weeks:

ing to create ways to reinvent government in Nevada. Following models in California and other leading legislative states, the governor has proposed various conservative taxes that will al-

leged offset the high cost of medical care, welfare, education, and other social programs within the state. Miller has received considerable opposition over an administrative proposal to renew and change the tax created in 1991 to help cope with high costs on medical care for the economically disadvantaged. The tax is targeted at hospitals and will make them accountable to pay more for their share of higher medical costs. This will be an intense battle in

TEEN-AGERS BEWARE: Senate Bill 272 introduced in the committee on transportation will require all teen agers to take a blood test to receive their driver's license. The bill was introduced

to curb drunk driving and driving under the influence of drugs or other narcotics. Although a progressive bill, the measure would require more bureaucracy and red tape for student drivers.

Other bills introduced would require room tax for strip and downtown resorts in Northern and Southern Nevada. The tax would create revenue to pay for increases in growth in Nevada. The hotel executives are worried that tourists will not be happy paying the extra charge and are pushing for other creative legislation to pay for the growth.

Assembly Bill 379 is a bill that would attempt to curb high crime rates and protect police officers during routine traffic stops. Introduced by Assemblywoman Chowning, D- Las Vegas, the bill would prohibit tinted windows on the front passenger or driver side of the automobile. The legislation follows a precedent set in the California legisla-

Lawmakers are looking into whether or not additional government documents should be open for public knowledge. Constituents are requesting that more documents be made public for the purpose of serving the open meeting law and avoiding

Governor Miller will not be considered for the "Education Governor Award," this according to his recent record with making less money available to existing programs and developing programs within public instruction. Assembly Bill 98 died in ways and means after the committee concluded that there is not enough money to fund new programs. State Education officials say that Miller's proposed per pupil support is the worst in twelve years. The status quo of 1991's fiscal allocation of \$3,312 per student will remain. State Education officials, school districts, and teacher alike will have to make their own "creative education" proposals to meet the needs of Nevada's children.

Assembly Government Affairs concluded that "None of the above" on election ballots can not win the election. Senate Bill 250 died after a subcommittee reviewed the statute and decided that "none of the above" is merely a protest vote and that the human candidate with the most votes must be appointed to the position they are running for.


