Who Can Obtain Your Credit Report?

Anytime you complete a loan application, you are essentially allowing a potential credit grantor access to your credit history. Credit report inquiries are kept in your file for two years. Keep in mind that too many inquiries may cause some lenders to believe that you are overextending yourself on credit and result in a rejection of your loan application.

Current creditors may also request updated copies of your credit report for periodic reviews as outlined in your account contracts. For example, a credit card issuer may request a copy if it is considering increasing your credit line.

Potential employers can also request copies of your credit report

to check the accuracy of your application and evaluate your financial responsibility. Insurance companies can review your report when underwriting insurance you may be considering for such things as your home, car or business. Potential landlords are also allowed to review your credit report before signing a rental agreement. Government agencies may also be permitted to review your report to determine your eligibility for certain government licenses.

How to obtain and Correct Your Credit Report

If you have been denied credit based on a report from a credit bureau, the creditor must provide you with the name and address of the credit bureau from which it obtained the report. As long as you contact the bureau within 30 days from the time you were denied credit, you can obtain a free copy of your report.

If you find that there is inaccurate information in your file, contact the credit bureau immediately. The law requires that the credit bureau investigate these items and remove information that cannot be substantiated. It must also notify the creditors who recently received erroneous information. Even if you haven't been denied credit, CPAs recommend that you review your credit report at least annually. Check the Yellow Pages under Credit Bureaus or Credit Reporting Agencies and call those that are located near your hometown to find out which one keeps your file.

Here is Las Vegas all has been peaceful in spite of some well intentioed, but misguided efforts such as "Peace Marches" and "Peace Picnics" etc. While all of this if fine in and of itself, it is a shame that it takes the threat of another uprising on the part of the slaves on the plantation to get the Metropolitan Police Department to move slightly off of their confrontational and inciting type of behavior, when it

comes to the African-American, Latino and poor white communities. Indeed if you are doing your job correctly you should not need "Peace Marches" nor "Peace Picnics", because you have in essence, through your very work and through your everyday demeanor, involved the community in your activities in that the community feels that you are indeed their police department and not an occupying army.
