MILK FOR KIDS

Milk For Kids, a community service project sponsored by Smith's Food and Drug Centers and Community Food Bank, benefits children and seniors with nutritional needs. Since its inception in November 1992, 1500 gallons of milk have been available to low income families with

children and seniors in the home. "The program works," said Food Bank Director Bessie Braggs. "Although we receive donations of many different kinds of food items to make up emergency food boxes, fresh milk has not been one of the items. Milk for kids has been the added resource we need and now milk is available to families who cannot afford to purchase it themselves."

Milk vouchers are purchased along with grocery items at a

checkout stand. The cost of the voucher is tax deductible. The vouchers are tabulated weekly and registered to agencies providing food assistance to families in need through the food bank.

Traditionally this is the time of year when donations of any kind go down even though the numbers of people needing assistance continue to rise said Braggs. Participating in the milk for kids program is effortless and gives an opportunity to help in such a meaningful way. Also Smith's Food and Drug Centers agreed to donate .50 for each redeemed voucher to community food bank's regular purchasing program.

A Message from Councilman Goynes

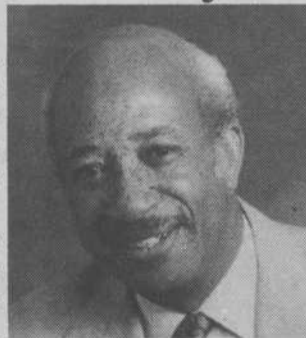
This is my personal letter to you, seeking your support in the upcoming election for the City Council of North Las Vegas.
