dollars. The new bill would offer students the opportunity to repay loans on an income-contingent basis through EXCEL accounts. "With loan repayment based on income, more students will be able to pursue careers in critically needed, but low-paying, public service jobs without fear of being overburdened with debt," Secretary of Education Richard W. Riley said.

The Student Loan Reform Act would also replace the current Federal Family Education Loan Program with a new Federal Direct Student Loan program. In this program, colleges and trade schools would use federal capital to make loans directly to students and their parents. An estimated \$4.3 billion could be saved through fiscal year 1998 as a result of lower government borrowing rates and the elimination of lender subsi-

"Students and taxpayers will benefit from a less expensive program," Riley said, "and students will enjoy lower interest rates, with simpler, more flexible repayment options. By cutting out middlemen and eliminating excessive profits, billions of dollars can be saved."

Riley said an orderly transition from guaranteed to direct loans would assure an adequate
