KCEP FM 88's Andre Michaels filled the Hard Rock with continuous vintage Kool & The Gang songs or rather WKOOL Cruising Hits.

The Hard Rock Cafe New York rocked the East Coast affair on Monday, May 10th to induct Kool & The Gang into the Hard Rock Hall of Fame. Later this summer, lead vocalist Skip Martin will be presenting some of his own personal memorabilia to the Hard Rock Cafe Las Vegas to be placed on display with other Las Vegas notables Andre Agassi and Slaughter.

Kool & The Gang has just released their newest compact disc entitled "Unite" in the United States. The album was released in Europe earlier this year. Kool & The Gang is known for classic hits such as "Celebrate," "Hollywood Swinging," "Jungle Boogie," "Cherish," "Fresh," and "Ladies Night." Mr. Black Radio himself, Jack the Rapper, even stopped in the Hard Rock to give a listen to the playback of "Unite."

"The album is slamin'!" expressed Michaels of KCEP.

Skip, who is the only band member that lives in Nevada, loves the exchange of community support in Las Vegas. Both top Las Vegas radio stations, KCEP FM 88.1 & KLUC 98.5 FM, began playing "Unite" in moderate rotation as soon as it was released.

Skip volunteered to auto-graph photos in exchange for donations to local anti-drug, anti-gang youth organization, SteetWise Alive. "I support anything that stands for something positive for our kids," stated Skip at the Hard Rock gathering. In addition, Skip will be an ambassador for the Las Vegas Academy of Performing Arts by speaking at assemblies in Clark County Schools to help increase minority enrollment.

Skip has been singing lead vocals with Kool & The Gang for the past five years. Previously, this trumpet extraordinaire achieved Grammy success with the smash single "Let It Whip" by The Dazz Band. Skip has penned three songs on the "Unite" release including "Better Late Than Never," "I Think I Love You," and the soft inspirational

"God Will Find You." Currently, Skip is managing his own company SMART Entertainment and is producing Czechoslovakian prodigy Darinka as well as local jazzist Laura Taylor.
