Over 22 million people visit this unusual state each year with it's luscious scenery and the famous Great Lakes. Both the upper and lower Peninsulas offer outstanding resorts and recreation facilities.

For those who love boating and fishing Michigan has more than 11,000 lakes. The beautiful forests cover more than half of the state.

Michigan touches four of the five Great Lakes: Erie, Huron, Michigan, and Superior. The state's shoreline is longer than that of any other inland state. Michigan consists of the upper and lower peninsulas. The two peninsulas are connected by the Mackinac Bridge which spans 5 miles across the straits of Micki-

Michigan is a year-round playground for people who love sports and the outdoors. Swimmers and skiers are attracted to the thousands of lakes, rivers; and streams. Camping and hunting enthusiasts are attracted to the scenic woodlands and thick forest.

In winter, many people travel to Michigan for ice skating, snow skiing, snowmobiling, toboganing, iceboat racing, and ice fishing. International ski-flying competitions are held in Ironwood at Copper Peak, one of the world's largest artificially created skiflying hills. Sightseers are drawn to the many beautiful waterfalls, sand dunes, and to the rugged "copper country" of the upper Western peninsula.

Visit exotic Mackinac Island which is a famous resort island in the straits of Mackinaw, located between the upper and lower peninsulas. Automobiles are not permitted on the island.

Detroit, Michigan's largest city, was founded as Fort Pontchartrain in 1701 by the French colonist Antoine Cadilac. It is called the automobile capital of the world and the motor city. The Detroit area produces more cars and trucks than any other part of the nation.

Henry Ford built his first workable automobile in Detroit in 1886. Three years later, Ransom E. Olds established Michigan's, first automobile factory in Detroit.

The Republican Party formally adopted it's name at Jackson in 1854.

Visit Greenfield Village, in Dearborn, a collection of historic buildings and landmarks restored by Henry Ford. Greenfield Village includes: buildings made famous by such persons as Abraham Lincoln, Thomas Edison, and Henry Ford whose museum is next to the village.

Don't miss seeing Michigan State University, located in charming Lansing Michigan, the capitol. It is rated one of the largest single-campus institutions of higher education in the United States.

You should also visit the University of Michigan in elegant Ann Arbor. This historic university maintains several museums and research insti-
