To make you out to be the big liar that you are let us name a few cases of real racism.

When the owners of Valley Foods decided to come to this town they were given 3 million dollars of block grant monies. They brought almost three hundred of their employees with them and hired less than ten from the community. Similarly, when Main Street Station Casino opened it's doors the owners were given more than 17 million dollars of block grant

monies that should have gone to the black business people in West Las Vegas.

When Mr. Steve Wynn decided to go into the hotel business one local bank loaned him all the money he needed.

Now contrast the financial opportunities that were afforded these white business men with what happened to a few of our black business men and women by financial institutions.

The Nucleus Plaza Center is situated on one of the most prime pieces of land in the entire city and yet it has experienced all kinds of difficulties convincing money lending institutions of this fact! Glad to report that Nucleus is beginning to see the light at the end of it's tunnel.

And then there is Ray and Ross Transport and Western Coach. Both of them could expand and hire many more people if there were other financial opportunities for them.

Until just recently, the largest food store that blacks owned in West Las Vegas could not propose it's food supplies at a whole sale rate unless they were purchased through a white grocery man. Always remember you, like the rest of us, are about three
