nancing. Finally, divide your total closing costs by
the amount you would save monthly. This resulting figure represents the number of months it will
take you to pay off your refinancing costs. If you
don't plan to stay in your house long enough to
reach this break-even point, refinancing probably
doesn't make sense for you.

#### TAX CONCERNS

CPAs remind homeowners to consider the tax implications of refinancing. First, it's important to note that although points paid up front when you buy or construct a home are fully deductible in the year of the purchase, points paid in connection with refinancing must be deducted over the life of the loan, whether you pay them in cash or add them to the loan amount. There's one exception:

If you plan to use part of the new loan for home improvements, the points that are attributable to that part of the loan are deductible immediately.

CPAs also point out that a reduction in your interest rate means a smaller interest deduction on your tax return.

If you have claimed extra allowances on your W-4 form based on your mortgage interest deduction and refinancing significantly reduces the amount of interest you pay, you may need to recalculate the number of allowances you have claimed.
