In contrast, Marge Schott's racist references to "her two million dollar niggers," "money grubber" Jews and "Japs" has not drawn any criticism for the White House. The President has yet to say anything in support of

the six Black Secret Service agents who denied service at the Annapolis Denny's restaurant on their way to protect his life at the U.S. Naval Academy.

The President stood with and defended Webb Hubbell for another Justice Department position. Hubbell was a member of an all-white Arkansas Country Club.

In this time of great national pain and division, the White

House must forge a moral high ground on which to conduct it's administration. The covenant for iobs and justice is the right path for economic and human development for the nation. Next week, June 10 - 12, the National Rainbow Coalition and the Citizenship Education Fund will hold a national leadership summit, "Rebuild America II: Honoring the Covenant" at which we will discuss a plan to help advance

this agenda of jobs and justice.
