LOCAL PODIATRIST ALLEGES DISCRIMINATION BY CULINARY UNION MEDICAL CLAIMS CARRIER

In an attempt to draw the public's attention to a problem that is affecting his podiatry clinic, foot specialist, Dr. John Hill, informed the Sentinel-Voice of how his practice is being grossly affected by racial discrimination in acquiring "provider status" for Culinary Union 226 and other union patient claims.

Dr. Hill and his wife Rayne' Hill said that they have come across nothing but obstacles after making a decision to locate his practice in West Las Vegas.

They are located at 1100 North Martin Luther King Blvd. in Suite C.

Rayne' Hill owns Crown & Glory Beauty Supply Etc., which is located in the same shopping Center, two suites from the podiatry office.

Dr. Hill said that after three attempts to be included on the medical provider list, two responses indicated that Prime Health, Incorporated — the carrier for Culinary Local 226 — stated that they were completely full of claim providers and had a long waiting list. A third request — all of which occurred in a

YOUTH IN ASSISTED HOUSING TO PARTICIPATE IN POSTER COMPETITION ON DRUG ABUSE

On Saturday, June 26, 1993 young residents of government-assisted housing will gather at Carey Arms Apartments, 1717 McDonald Court in North Las Vegas, to participate in a poster competition on the dangers of drug abuse. The "Poster Day" is being sponsored by the Southern Nevada members of the Assisted Housing Management Association (AHMA): local suppliers, law enforcement officials and sports celebrities are bonding together in a community-wide effort.

Posters are submitted annually by children from K-12 grades who reside in AHMA-member complexes, interpreting a theme which always deals with drug abuse.

The poster competition is conducted under the auspices of the National Assisted Housing Manage-

Young most recently served since 1989 as a Battalion Chief. He was promoted to Fire Captain in 1982, prior to which he also worked in the training division for three years.
