mins, he became president of a small chemical distributorship in Indianapolis. Under his leadership, the company's sales increased from \$300,000 to \$5million. Seeking the control and flexibility of ownership, Mays established his own chemical distributorship in 1980.

Mays Chemical Company Inc. provides over 300 solvents, additives and preservatives to food and pharmaceutical manufacturers, including Kraft General Foods, Eli Lilly and Company and Pillsbury Co.

AUDIT REVEALS UNEMPLOYMENT INSURANCE PROPERLY PAID TO MAJORITY OF CLAIMANTS

CARSON CITY- The Nevada Employment Security Department (NESD) released results of it's 1992 quality control audit of the state's unemployment insurance (UI) benefit payments today. The audit revealed that a significant majority of claimants were properly paid unemployment insurance benefits during 1992.

Analysis of the audit determined that proper payment in 80.9% of UI claims filed and paid with at least one benefit check in 1992.

Department Executive Director Stan Jones said, of the 19.1 percent error margin detected in the 477 UI claims comprising the audit, claimants were responsible for 83.7 percent of the errors
