MOTHER OF SLAIN YOUTH ASKS WITNESSES TO COME FORWARD

Teresa Morgan, mother of Isaac Marable, a seventeen-year-old youth who was shot and killed on the parking lot near Frank Hawkins Sports Lounge on May 29, 1993, has taken her son's case to the public in order to appeal for any witnesses who were present to come forward.

Morgan said that the youth who allegedly shot her son five times with a .25 caliber revolver (17 year old Bruce Willis who was arrested) has begun to rally witnesses in his defense, alleging that Willis acted in self defense.

According to Morgan, there were no casings found from a second weapon, nor a second weapon at the scene of the homicide. Morgan never got out of the vehicle in which he was murdered. "I would like to make a public appeal to anybody that was there on the night of the shooting - Saturday morning, May 29, 1993 at approximately 3:15 a.m. - that may

have witnessed what happened to please come forward. I need your help."

"My son's killer could possibly go free if more witnesses do not come forward. I am the only hope that my son has to see that justice was done and I was not at the scene of the crime."

RAY & ROSS TRANSPORT RECEIVES AIRPORT APPROVAL

Ray & Ross Transport, Inc. recently received approval to perform airport transfer service at McCarran Airport. The approval follows nearly four months of deliberation by the Nevada Public Service Commission. Approval was given this Tuesday during an agenda meeting with commissioner JoAnn Kelly providing the recommendation for approval.

Commissioner Kelly gave various reasons for approval, yet noted the escalation in ridership at the airport as a major factor. Commissioner Kelly said the chartered growth at the airport is reflective of the need for an additional carrier. Kelly cited the company's substantial business reputation which included over eighteen years of participating in the marketplace, and ten years of providing service to Nevada Test Site employees. Company officials were noticeably anxious as Commissioner Kelly read her decision during the

Tuesday hearing.

Kelly's favorable comments were followed by her opinion on the company's questionable financial profile. She reflected on reasoning used in opposition to the company's initial application. This position was presented by the PSC staff as well as the inter-

veners to the application.

During the late March hearings, a variety of transportation companies opposed Ray & Ross' application based on the company's unfavorable financial profile. These companies included Bell Transportation, Greyline of Las Vegas,
