In this same article there were interviews with a couple of local politicians. One made a statement that the best people to oversee police officers are other police officers. Throughout the country it is clear, that police officers do not now, norhave they ever, had the ability nor the willingness to objectively evaluate their function, nor have

The state government is paying \$250 million per year to house three prisoners. Although virtually all economists and social scientists state that illegal immigrants generally produce jobs and greater wealth to everyone within the society, the false impression that they constitute a negative factor within the economy has become widespread.

Moreover, the projections for the next several decades indicate that California's pluralistic ethnic environment will become the norm for much of the country. According to the Asian Pacific American Public Policy Institute, the Asian America population between 1990 and the year 2000 will triple to about 20.2 million. Latinos will surpass African Americans as the highest single ethnic majority by approximately 2010. In thirty years, more than forty percent of the total American population become a distinctly "second language.

Significantly millions of these new ethnic minorities do not consider themselves to fit the standard racial categories of "black" and "White." In the 1990 census, for example, 51 percent of California Latinos stated that they were "not white, black, Indian or Asian" and selected the racial designation of "other."

Despite their status outside traditional racial boundaries, the nonwhite newcomers have quickly encountered the familiar racist violence which African Americans know only too well.

(Continued from Page 17) tions, if ultimately approved, are made available to all patients. They urged the architects of pending national healthcare reform to provide insurance that guarantees that all patients receive all medicines approved by the Food and Drug Administra-

Their plea was made in the wake of Congressional action that allows states to conclude restrictive formularies in their Medicaid programs, which provide healthcare and other services to the nation's poorest residents. Restrictive formularies restrict certain medicines from coverage by a state Medicaid program. Often, the newest, most effective therapies are restricted.

Butcher, in an article that accompanies the new PMA survey, said that restrictive formularies pose serious problems for minorities "since recent research indicates that racial and ethnic differences may make a difference in how a prescription drug works. It is especially important that patients have access to all available medicines. There is no such thing as a 'onesize-fits-all' drug.

"While scientists strive for cures in the laboratories, the rest of us must work to see fruits of

pharmaceutical research are accessible to all Americans. Medicines should be available to every person who needs them they should not be unattainable luxuries that poor people can only dream about.'

PMA's Allnutt said the survey "is a recognition that African Americans have special healthcare needs - and it shows that our industry is committed to meeting those needs. Patients of the same race and sex can react guite differently to the same medicine. And it is now becoming increasingly clear that racial and ethnic factors may affect how an individual patient responds to a particular drug."

risk of hypertension.

On face value, one would question those findings because they seem to play into the stereotypes of skin color.

In an editorial which appeared in the Journal of the American Medical Association, Howard University College of Medicine Professor, Dr. Albert Murray, Jr. said, "A combination of disadvantaged socioeconomic status and a behavior pattern of repressed hostility in a dark skinned individual may be the marker of the at-risk person."

Granted, the study may not have all the answers to the problem, but it does establish for the first time, a definite link between race and high blood pressure. Now we have scientific evidence to back up what we've known all along --- that the stressful nature of life, especially so for Black men, has severe health consequences. Take heed.
