AARP HOSTS RUBY GARLAND NIGHT

"I would never become involved in any project if I didn't enjoy it." These are the words of Ruby Garland, a very energetic and dependable woman, who wears many hats in her daily routine and wears them well.

Ruby and her husband, James, moved from Buffalo, New York to Hawthorne, California in 1949 where he was employed in the Ammunition Plant. They later moved to Boulder City, Nevada and decided to make Nevada their permanent home.

Ruby was an instructor at the Las Vegas Beauty College and worked as a beautician in the Beauty Shop of the Dunes Hotel.

At the request of Mike Callaghan, former Governor of Nevada, Ruby served as a licensed Health Inspector for the State Board of Cosmetology. She retired in 1984. The same year, Governor Bryan declared August 24 as Ruby Garland Day and Senator Harry Reid presented her with a Congressional Proclamation.

Ruby was the first black woman delegate representing the State of Nevada at the AARP Minority Affairs Spokesperson for the State of Nevada.

In 1987, Ruby organized the AARP Northwest Chapter 4395 in the State of Nevada. The Chapter declared October 21, 1993 as Ruby Garland Night and she was presented with a beautiful plaque by the President, Thomas Leigh in appreciation of her services.

Among other hats that Ruby wears very well are:

Board member of the Nevada Lung Association, Board member of Charter Hospital, the Neighborhood Revitalization Program, a member of the Senior Nutrition Council, and is presently a member of the advisory Board of Nevada Geriatrics Education Center sponsored by the U.N.L.V. Medical School.

For two consecutive years, Ruby served as Basileus of Alpha Rho Chapter, Gamma Phi Delta Sorority. She was also President of the Drifter Club and the Cosmetique Club.

Ruby's husband, James is deceased and she and her handsome son, Clifford are residents of Las Vegas, Nevada.
