SCHOOL DISTRICT FACES CRITICISMS FOR PRIME 6 PHASE II PROPOSAL

(Part One of a Three Part Series)

By Victor Ingram and Ramon Savoy The announcement came on December 1; 1992. The Prime 6 Plan had received approval from the Clark County School District Board of Trustees following months of protest and negotiation. The plan, according to proponents, would correct the destructive affects of busing on minority children by allowing them an opportunity to be educated within their own community. Schools within the predominantly African American West Las Vegas community were restructured for neighborhood children to be given a choice. H.P. Fitzgerald Elementary School opened becoming the first new school to open in the eco-

Phase II, however, has received mixed degrees of support from teachers and parents. Phase II plans a full scale implementation of Prime 6, allowing all parents the option to keep their children within neighborhood confines for grades K-12. The plan strives to

standardize the district's grade structure, but to some, threatens total segregation. Some have speculated that White parents will leave in masses once offered an option to not sending their children to Westside schools, which have traditionally been older and deficient in teaching resources as well as personnel.
