Despite all of our efforts, we are losing ground in the struggle for equality. Our "race" becomes the essential vehicle through which we seek to assert our humanity and struggle for self-respect. Yet

if we define our politics simplistically, as a narrow definition of ourselves - whether as African-Americans or Latinos only, or working people or women only, or Christian or Jews onlywe surrender any hope for creating an agenda to liberate all people who are oppressed. Our struggle must be to destroy the oppressive institutions of racism and the very idea of race itself, while maintaining our cultural heritage and identity of struggle.

We cannot accomplish this by degrating others. The farthest boundaries of our identity should never stop until reaching the horizons of a common human-

Keep in mind, too, that if you combine business with vacation when attending a convention, your tax deduction could be limited. What's more, if your spouse accompanies you on a business trip after 1993, you can deduct his or her expenses only if the individual works for you and has a bona fide business reason for attending the event.

Finally, CPAs urge you to remember that you must be able to substantiate all travel costs with appropriate records.

That has allowed a clear pattern of racial discrimination in the way the death penalty is administered. Most murder victims in the U.S. are African Ameicans, but the death sentence is more likely in cases where the victim was white.

The government's General Accounting Office reports that blacks who kill whites get the death sentence at "nearly 22 times the rate of blacks who kill blacks and more than seven times the rate of whites who kill

This most serious of penalties remains trapped in a web of racial prejudice and irrational arbitrariness, and current trends can only make the problem worse. The Supreme Court majority seems determined to

restrict the rights of appeal and continues to uphold the death penalty even in cases where evidence of arbitrariness is clear.

And the crime bill now before the Congress would greatly expand the death penalty for federal crimes although most experts agree that the penalty has no impact on public safety and does not deter criminals from committing those crimes.

Further, no matter how fair a trial is, mistakes can happen. Over the past two decades, 48 people have been freed from Death Row because evidence of their innocence was discovered. Proponents of the death penalty claim that the Constitution does not bar it and even refers to "capital" crimes. But the Constitution is a living document, and what passed for normal state behavior in the 1970's can no longer be deemed

(Continued from Page 7) sion) registered broker/dealers who conduct business primarily in the U.S. are automatically SIPC members. There are some exceptions to this rule. Firms that distribute mutual funds and variable annuities exclusively, firms that act as advisors to investment companies and certain U.S. government securities dealers are not SIPC members either.

SIPC funds come from two sources: assessment of it's members and investment income. SIPC also has credit lines with banks and other financial institutions which it may borrow funds as needed. Today these credit lines exceed one billion dollars.

Since SIPC began in 1971, there have been 244 customer protection proceedings. 330,000 claims have been fully satisfied and 319 were partially satisfied. Many customer accounts today exceed the limits of SIPC protection. To provide additional coverage, many brokerage firms carry excess SIPC insurance.
