* Small businesses, targeted to minority-owned business.

* Public and private partnerships, including participation in housing construction and community development lending partnerships.

Dr. Benjamin F. Chavis, Jr., stressed the importance of the CDRC's presence in Nevada's communities. "The CDRC will reach out to businesses with direct, hands-on assistance, aggressive advertising, and personal contact with a wide variety of Nevadans," Chavis

The CDRC will employ three full-time individuals, who will work directly for the NAACP. These employees will have the task of carrying out the goals of the NAACP, U.S. Bank, and the CDRC, on a statewide basis,

according to Chavis.

In addition to assisting people with the U.S. Bank loan application process, the CDRC will offer credit and financial counseling for consumers and businesses.

Congressman Jim Bilbray praised the establishment of the CDRC in his congressional District. "The development of economic opportunities in our cities will only thrive through programs such as these," said Rep. Bilbray. Also, two single mothers will be given \$500 awards to use toward a college education or vocational training.

Like his father, Martin Luther King III is a human rights advocate, community activist and political leader. He has been actively involved in world-wide humanitarian efforts to eliminate poverty and starvation, essential programs to nurture the personal, educational and skill development of youth and significant police initiatives to maintain the fair and equitable treatment of all citizens.

In 1986, Mr. King was elected to the seven member Fulton County Commission as an atlarge representative. As a Commissioner, Kingdrafted legislation which created the Contract Compliance/Equal Employment Opportunity Department. The Department regulates minority business participation in county contracts and ensures equal employment opportunities for all Fulton County employees. In 1990, Commissioner King was re-elected to the Fulton County Board. Later, his colleagues elected him to serve as Vice-Chairman of the Commission. As Vice-Chair, King's initiatives included strengthening the personal income disclosure proviand restricting county employees and elected officials from soliciting business with the County for at least six months after the end of their tenure.

King received his Bachelor of Science Degree from Morehouse College in Atlanta. He is a member of numerous civic, community and human rights of the North Las Vegas Police organizations such as the

NAACP, National Association of County Officials and National Association of Black County Officials. He is a member of the Board of Directors for the Southem Christian Leadership Conference (SCLC) and the Martin Luther King, Jr. Center for Nonviolent Social Change. In addition, he has received numerous awards and commendations.

Martin L. King III, is the second oldest of the four children of the late Dr. Martin Luther King, Jr. and Coretta Scott King, and played a major role in the successful lobbying effort to make his father's birthday a national holiday. He is a member of Ebenezer Baptist Church in Atlanta, Georgia where he
