CAT REVISES SUMMER SCHEDULE & FARES

Citizens Area Transit will begin a modified schedule effective Saturday, June 25, at 5:30 a.m., the beginning of the service day.

New customer assistance materials, including system maps and CAT Guides (a complete listing of all 31 routes and timepoints) are available with updated information.

This literature can be obtained at over 700 locations around the greater Las Vegas area, including the Downtown Transportation Center and the Regional Transportation Commission offices at 301 So. Clark. Requests to have literature mailed, questions about routes and times or general CAT information should be directed to CAT's Customer Assistance Representatives at CAT-RIDE (228-7433.)

In addition to the schedule revisions, CAT will modify the one-way, cash fare on routes 301 and 302, effective June 25. The one-way cash fare on these routes will permanently change from \$1.00 to \$1.50 per person. The fare increase in these routes, which service the tourist corridors of Las Vegas Blvd. to the Downtown area, will only apply to the cash fares, and will not impact any individuals eligible for reduced fare options or those paying with any form of CAT Pass, CAT Coin tokens, or those transferring onto routes 301 or 302 from other CAT routes.

position in 1989. Under his leadership, the Tribune has adopted a four-color printing format, has moved from a twice-a-week to a three-time-a-week publishing schedule, has added a monthly magazine and has become the first African-American newspaper with a weekly television magazine insert.

tions in the routes will allow better service for citizens and visitors of the valley during the summer period when individual's commuting schedules are traditionally altered somewhat. Citizens Area Transit is a service of the RTC and operates 31 routes over approximately 25,000 service miles on a daily basis.

The fare increase in the lucrative tourist corridor was designed to generate additional revenues which could be used to expand CAT's capabilities throughout the service area. The Commission researched the feasibility and merits of the increase and determined that the additional revenues would be substantial enough to impact CAT's future expansion capabilities. Additionally, the Commission wanted to insure that local citizens who utilize routes 301 and 302 could ride CAT to gain access to employment or leisure activities without having to incur an additional expense. The increase in cash fare only mandates that riders using token, pass, authorized discounts and transfer options would continue access at the lower fare price. are willing to use that leverage to force concessions on foreign policy issues affecting Africans.

Earlier this year, as the political crisis in Zaire threatened to undermine the gains of the National Sovereign Conference and the role of the pro-democracy transitional government, I strongly lobbied key member of the Congressional Black Caucus to apply direct pressure on President Bill Clinton. The CBC

had an obligation, I told them, to insist that Clinton use his considerable influence over Mobutu to force him to abide by the new constitution and transfer power to the transitional government. I informed key members of the CBC that I would report directly to the African American community whatever actions they decided to take.
