Five years ago, Supreme Court Justice Sandra Day O'Connor wrote her opinion in the case; City of Richmond vs. J.A. Croson, part of which states that entities that wish to enact a "race conscious" program must demonstrate that discrimination

That decision has quite definitely changed the way state and municipalities establish minority business development programs, setting in motion a growing effort on the part of public entities to strive to ensure the inclusion of minority businesses in their procurement opportunities. A factual predicate, more commonly known as a "disparity study," constitutes the first step in this process of inclusion.

Disparity shows differences between a public entity's utilization of women and minority owned businesses compared to their presence in the marketplace where the public entity operates. The disparity study is comprised of a range of information and input, which include anecdotal testimony, historical evidence and statistical data. While the disparity study can infer that discrimination exists, the Croson decision requires that the legislative body make a finding of discrimination. Once the legislative findings are concluded, policy initiatives are then taken to eradicate the discriminatory practices.

Often, the entities evaluated in these disparity studies are chagrined by the results, which because of the strict guidelines for conducting the studies are based on factual conditions. It seems that in spite of the protestations of many to the contrary, what consistently emerges during the disparity study process is the existence of unresolved sexism and racism, where separations and misunderstandings among different racial, ethnic and cultural groups run deep.

Some in the economic mainstream balk at minority business development programs, setasides and other such efforts to ensure that women and minority owned businesses are included in the opportunities for procurement contracts. In Croson the Court cautioned public entities not to become "passive participants" in the "evil of private prejudice." The spirit of the caution

Croson also requires that any race-conscious program an entity enacts must be "narrowly tailored" to address the identified discrimination, since the program will be examined under a legal doctrine known as "strict scrutiny," the highest standard of judicial examination.

One of the key areas in measuring disparity is to first assess the availability and capabilities of minority owned businesses in the relevant geographic area in which the public entity conducts its procurement activities. For accurate measurement, a sound methodology and a clear definition of what constitutes available minority and non-minority owned businesses. As a small-budgeted public station, most of KCEP's on-air personnel are volunteers. Only a handful of its staff are on the payroll.

To the loyal, dedicated volunteer staff of KCEP, I applaud what you do to keep the station running smoothly, 24-hours a day. With increased financial support from the public, you could do an even

Is KCEP a "Black" station? Technically no. Because its parent company, EOB is not a "White" or "Black" institution per se. It's because the license is held by an anti-poverty agency whose programs are physically situated in an area of greatest need, West and North Las Vegas, that KCEP is thought of as a Black

EOB feels that now is the time for KCEP to make a dramatic change in image and format. A first step was taken several months ago by outlawing "gangsta rap" from the airwaves.

To be successful in the future, KCEP must establish a solid financial base through fundraising. Ultimately, that means asking faithful listeners like you to make regular donations. Keep in mind that donations to KCEP are considered charitable contributionsthe same as for United Way or any other bonafide charity.

There are differing opinions about what specifically needs to be done to make KCEP a viable station. I urge you to write and let them know what type of programming you would like for KCEP

The talk is that KCEP listeners can be had-that they are fickle. And that they will easily defect to any commercial station that would try to clone KCEP's soul music format. Remember. For a brief time here in Las Vegas there was 1340 AM, Motown and more. Then there was the KEY, 93.1, and now there's KXTZ, 94.1. All commercial stations, experimenting with Black music programming to steal KCEP's listening audience.

I should remind you that formats for commercial stations come and go because they are determined by the ratings over time. KCEP is a public station. It doesn't depend on ratings for its survival. As long as we have a station like KCEP that is committed to giving us what we want through thick and thin, can we afford to turn our backs? Absolutely not. KCEP is the only true African American broadcast outlet in Nevada. Let's get with the program!
