the babies can thrive.

She is a member of the American College of Obstetricians and Gynecologists and an associate member of the American fertility Society. She is also active in the Clark County Medical Society, and the Nevada State Medical Association and their affiliated obstetrics and gynecology chapters.

Dr. McConnell came to Las Vegas in 1992. In her short time with the Department she received the Association of Professor's of Gynecology and Obstetrics (APGO) Excellence in Teaching Award and the Council on Resident Education in Obstetrics and Gynecology (ACOG) National Faculty Award for excellence in resident education.

Infertility, which is defined as at least one unsuccessful year of attempts to conceive, affects over 11,000 couples in the Las Vegas area. Projections suggest that one out of every 10 couples who end up in divorce probably suffered from infertility. The causes for infertility are almost equally divided between the sexes and, in some cases, both partners may be a factor. Therefore, contray to popular belief, females don't have a monopoly on these problems. Approximately 40% of all infertility cases can be traced to the male.

"By using in-vitro fertilization, triplets were recently born, two girls and one boy, to a young couple. With the aid of donor eggs, one of our 49 year old female patients gave birth to a healthy infant after being childless for twenty years" sayd McConnell.

Dr. McConnell concludes by adding that "I'm sure a lot of people will be surpirsed to know that the technology to actually influence a couple's chances of selecting the sex they want is closer than you might think. In fact, we hope it will be as close as the Institute in the very near future."
